

## Oakfield Show Home Competition Ts&Cs

1. This Oakfield Show Home competition (the "Competition") is promoted by Nationwide Building Society (the "Promoter"), whose registered office is at Nationwide House, Pipers Way, Swindon, SN38 1NW. By entering the Competition, You hereby accept these Competition Terms and Conditions. By entering the Competition, You agree and acknowledge that the Promoter is permitted to receive your registration data. 2. The Competition is open to art students and artists living in Swindon or within a 5 mile radius of Swindon aged 15 or above on the closing date of the Competition. The Competition is not open to employees, contractors or temporary workers of Nationwide Building Society.
3. The Competition is free to enter and no purchase is necessary.
4. In order to take part in the Competition, You must create an original design, based on the theme of Swindon's heritage, as set out in the design brief provided [here](#) and submit your design (together with you name, contact details, age, college if applicable and a short description of your design and inspiration) by email to [Oakfield@nationwide.co.uk](mailto:Oakfield@nationwide.co.uk). Only two entries per person are permitted.
5. The opening date for entries is **midnight on Thursday 21<sup>st</sup> October**. The closing date is **midnight on Sunday 2<sup>nd</sup> January 2022**. Entries received after this time will not be accepted.
6. You must only submit appropriate content, and the Promoter reserves the right to remove or disqualify any content deemed inappropriate. Submissions will be judged on their originality, relevance of design to brief and how well it captures Swindon's heritage
7. You must ensure that your submission and artwork/image is entirely your **own original** work and does not incorporate, copy or borrow from the work of others. You confirm that any person depicted in a submission has granted permission to be portrayed as shown.
8. Artwork rights remain with You and any materials produced incorporating your submission will be sent to You once Oakfield's show home is no longer in use. You understand that any submission to the Competition may be used by the Promoter for marketing and promotional purposes of You the author and the Competition. You hereby grant the Promoter a non-exclusive, irrevocable licence in each Competition submission throughout the world in all media for any use connected to the promotion of You the author and the Competition.
9. The Promoter accepts no responsibility for entries not successfully completed due to a technical fault of any kind.
10. No more than 4 winner(s) will be chosen from all correct entrants. The winner will be selected from all entrants by an independent person in accordance with the criteria outlined above by **Friday 7<sup>th</sup> January 2022**.
11. 1<sup>st</sup> place winner will receive a £100 voucher for Hobbycraft, any runner-up places will receive a £50 Hobbycraft. Both the winner and runner-up places will have their design digitalised and transferred to cushions and/or soft furnishings (or, at the Promoter's discretion, displayed in an alternate manner) in Oakfield's show home. Winner and runner up names and details will be displayed in the show home for prospective buyers of the home to see and their art will be promoted via Oakfield's social media channel and website.
12. Each winner will be notified by email or telephone (using details provided at entry) by **midnight on Wednesday 12<sup>th</sup> January 2022**. If a winner does not respond to the Promoter within 7 days of being notified by the Promoter, then the winner's prize will be forfeited, and the Promoter will be entitled to select another winner in accordance with the process described above.
